NOTES

Bulk means "Rentable Area" as defined by SAPOA.

The bulk is allocated by the Township Developer (Milnerton Estates Aska Joint Venture [MEAJV] or the Milnerton Estates [ME]) and is drawn from the applicable Parklands / Rivergate / Pegasus Park "Bulk Pool"

The term "bulk" is used generally in the table above irrespective of whether the Approval makes reference to Commercial, Mixed Use or Industrial bulk. In this table bulk is bulk.

Bulk rights are recorded in the Agreement of Sale between the Milnerton Estates and the first purchaser.

Subject to availability, additional bulk may be purchased from the Township Developer's Bulk Pool.

The bulk allocated above may change as additional bulk is purchased or re-allocated by the Joint Venture.

The legal fees applicable to uplifting or amending any title deed to reflect any adjustment authorised by the Township Developer, will be for the account of the applicant or the property owner / applicant.
